Education Centers - ECC operates two green buildings it renovated in the first Brownfield restoration project in the District. Earth Conservation Corp has been a leader in the adaptive reuse of abandoned river front building that have been converted into state of the art community environmental education centers. The centers were renovated with youth from the community alongside the Navy Sea Beas. Both Centers are vital convening spaces and provide community access to the river through our youth led river life programs. The educational centers are also used for our environmental education programs and as outdoor classrooms where our young people are trained in Low Impact Developmental jobs and landscaping. The Matthew Henson Earth Conservation Center has the first green roof that was installed in the city and has inspired countless others. In addition to the green roof, the youth created Henson Park which has a river walk and three rain gardens that are used for filtering storm water run-off and also used for education and training.

4b (Code:) (Expenses \$ 95,834. including grants of \$ 30,600.) (Revenue \$ 32,641.)

Workforce Readiness/Career Training - Provides disconnected and at-risk youth ages 17-25 with environmental workforce developmental skills through completion of community restoration projects on the Anacostia River and its tributaries. Our young people go through the Philip Roy workforce development curriculum during their term of service with the ECC. This training provides essential job skills development that will help our youth as they move into internships and jobs upon graduation. ECC has several employer partners including National Park Service, DC Water, American River Taxi and Gang Plank Marina

4c (Code:) (Expenses \$ 199,853. including grants of \$ 8,336.) (Revenue \$ 156,030.)

Environmental Leadership - This program promotes stewardship of the Anacostia River. Corps members lead standards-based environmental education for school children and river based environmental education. Corps members participate in our raptor education program. Our young people give live raptor demonstrations to school students in the DC metro area, members of the community and at National parks. This opportunity provides environmental education to the city and gives our young people invaluable workforce experience by developing their public speaking skills. We also run our river programs at both facilities which provide our young with boating experience and give the community a chance to engage on the Anacostia River. We also worked through the development community and the city to expand the capacity of the Earth Conservation Corps center to create Diamond Teague Park and Marina. Environmental Protection Agency mentoring of corps leaders continues to support the growth of their abilities and the expansion of their outreach. The youth led river recovery has attracted the deep engagement of leading scientists, educators and technicians from The DC Department of Environment, the US Fish and Wildlife Service, the National Geographic Society, Metropolitan Police department and the See Form 990, Page 2, Part III, Line 4c. 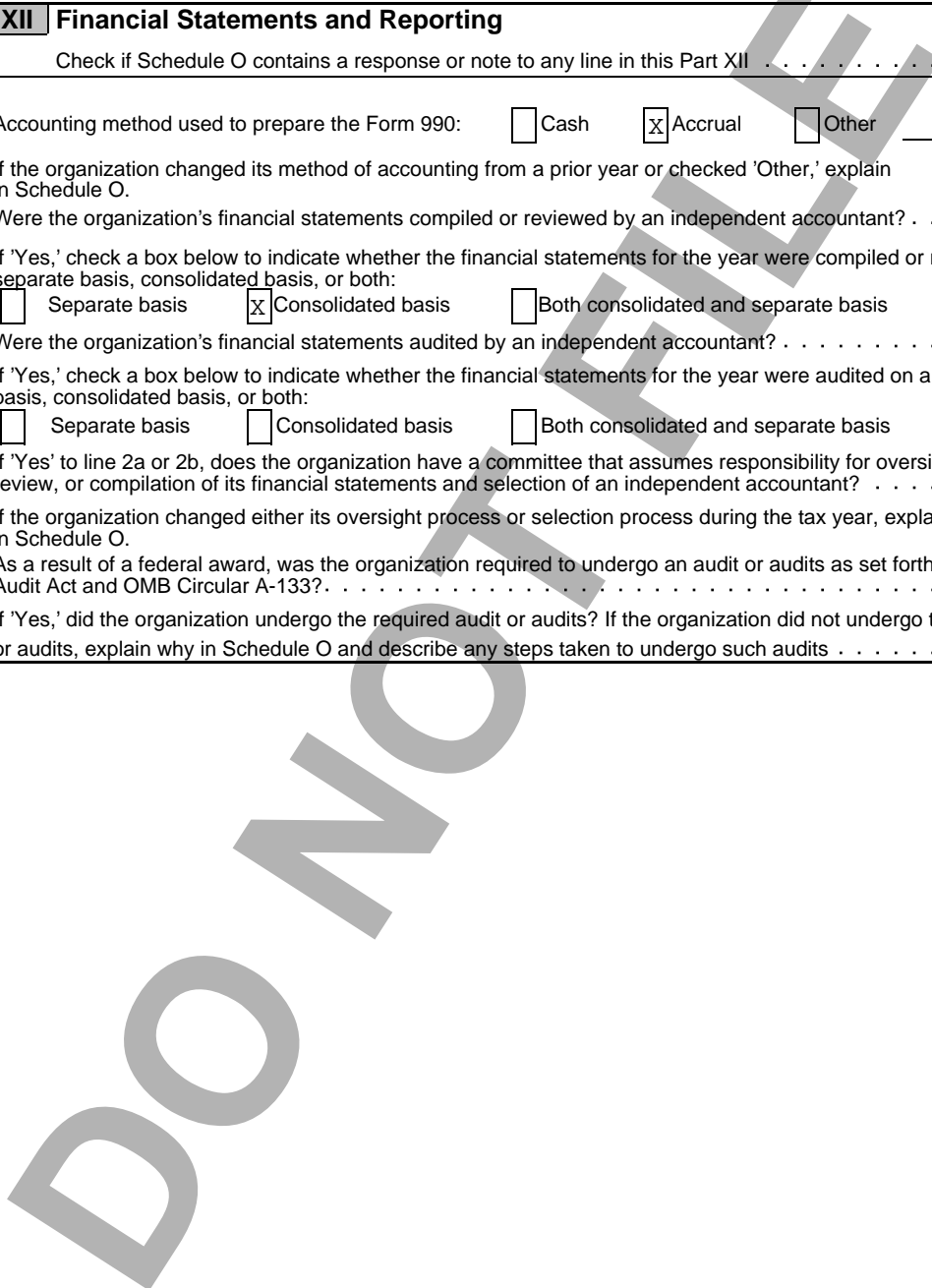
